Overview

RICOH TotalFlow DocEnhancer, a plug-in to Adobe Acrobat Professional, allows you to visually define and display enhancements on fully composed PDF files. Enhancements include creating bar codes and text and adding images and hidden areas. TotalFlow DocEnhancer is a smart and intuitive product that allows print providers to quickly enhance PDF files to streamline the production process.

With this release, TotalFlow DocEnhancer introduces a new Verification Feature. Today, many applications are critical – from health care communications to highly personalized marketing materials - and require tracking and reporting to prove every piece was printed properly. This new feature allows users to easily add barcodes to PDF statements, letters, or other types of documents and to link those barcodes to a post production verification process.

In addition, several new capabilities have been added to the base DocEnhancer software tool. This release adds enhanced conditional logic for object placement as well as expanded font capabilities.

Highlights:

- Provides a new Verification Feature to add integrity, reporting, and reprint capabilities for applications that require tracking and control
- Enables complex rules to conditionally place images based on data in the print file
- Enables expanded font options by using your own TrueType fonts throughout the TotalFlow DocEnhancer tool

Description

TotalFlow DocEnhancer

TotalFlow DocEnhancer provides the ability to define document properties and editing rules to be applied to PDF print files. TotalFlow DocEnhancer also allows you to visually define and display enhancements, including creating bar codes and text, and adding images and hidden areas.

***New* TotalFlow DocEnhancer Verification Feature**

From HIPAA and Regulation Z requirements to highly personalized marketing materials, much of today's printed output requires perfection. Every piece needs to be printed, and printers have to be able to track and prove the printing was done properly. An orderable, add on feature to the base TotalFlow DocEnhancer, the TotalFlow DocEnhancer Verification Feature allows users to track individual pieces within a larger production job to ensure that the individual pieces are properly produced.

The Verification Feature enables the user to add a special barcode that uniquely identifies each piece within a job for verification. The barcode can then be scanned at any point in the production process to track its progress. The scan file is loaded into DocEnhancer's verification tool, automatically reconciling which pieces are missing and allowing the user to create a reprint job containing only the missing pieces. At any point in the verification process the user can create a visual report showing percent complete, including details for each scan file loaded.

This new feature opens the door for basic Automated Document Factory capabilities, including tracking, accounting, reprinting, and reporting.

Enhanced Conditional Logic

This release of TotalFlow DocEnhancer adds a new Rules Manager, allowing users to easily build and edit complex conditional logic statements. The rules can be applied to any of the objects being added to or extracted from the original PDF. For example, a promotional advertisement could be added to statements in a certain zip code, but only when their membership level is one of the top three tiers. For all other statements, a default promo can be added.

Expanded Font Support

TotalFlow DocEnhancer now has the ability to add text to PDF documents utilizing any fonts installed on the operating system. DocEnhancer will embed the appropriate fonts in the enhanced PDF, maintaining the portability of the document across systems and through production.

System Requirements

TotalFlow DocEnhancer can be installed on a client workstation. The workstation must be running one of these operating systems:

- Windows XP Professional with SP3 or above – 32 and 64 bit
- Windows 7 Professional with SP1 or above – 32 and 64 bit
- Windows 8 – 32 and 64 bit.

In addition, the following hardware and software is required:

- Adobe Acrobat X Pro version 10.1.1 or above or version 11
- Sun Java JRE 1.7 Update 6 or higher
- 2 GB RAM

Ricoh includes one year of software maintenance with the initial license acquisition of each program acquired under the terms of International Agreement for Acquisition of Software Maintenance, which does not require customer signatures.

While covered under the terms of the software maintenance agreement, Ricoh provides you assistance for your routine, short-duration installation, and usage (how to) questions, as well as code defect support and access to PTF updates, releases, and versions of the program.

Ricoh provides assistance via telephone and, if available, electronic access, only to your Information Systems (IS) technical support personnel during normal business hours (published prime shift hours) of your Ricoh support center. This assistance is not available to your end users. Ricoh provides Severity 1 assistance 24 hours a day, every day of the year.

Software maintenance does not include assistance for the design and development of applications, program modifications, print data-streams; your use of programs in other than their specified supported operating environment, or failures caused by products for which Ricoh is not responsible under this agreement.

Limited Warranty

Ricoh warrants that when the program is used in the specified operating environment, it will conform to its specifications. The warranty applies only to the unmodified portion of the program. Ricoh does not warrant uninterrupted or error-free operation of the program or that Ricoh will correct all program defects. You are responsible for the results obtained from the use of the program. Ricoh may provide you with access to databases containing information on known program defects, defect corrections, restrictions, and bypasses at no additional charge.
