## Description

---

Ricoh announces the release of InfoPrint Ink Savvy. Designed as an all inclusive software solution for preparing graphic elements for use in document composition, as well as fully composed PDF files, this software uses the customized CMYK optimization technology to reduce final ink usage significantly while maintaining the full visual color fidelity of the unprocessed color file. Each element within the file is handled as a discrete element assuring maximum saving while maintaining faithful visual color fidelity.

Ink Savvy is a software tool designed for customers who control or support the document composition process where color normalization and optimization of variable document content resources is critical for achieving maximum color fidelity and ink utilization.

The software is ideally suited for full multi-paged production PDF files or for AFP resource preparation where original source elements may be provided in a full range of color spaces and file formats which have not been specifically prepared for the colors space, gamut or paper to be utilized with the InfoPrint 5000, but need to be processed to achieve finely tuned color gamut and color fidelity while minimizing the total amount of ink that will be required to produce these results. Customers who also create Postscript and PDF variable documents will also realize significant benefits.

The tool can convert and optimize all color spaces including, CMYK, RGB and spot colors, such as Pantone colors to a color corrected and color optimized CMYK color for the InfoPrint 5000 printer, thus improving color quality and virtually eliminating pre-press color adjustment work. Ink Savvy can handle PDF, JPEG, TIFF, and EPS files. In PDF files, each image or graphic element is handled as a discrete element, assuring maximum fidelity. For PDF objects the software also utilizes the full Adobe PDF libraries to flatten transparency, remove unused objects and optimize PDF structure.
