## What's New in Release 1.3.0.0?

These new functions and updates are included in RICOH Auto Color Adjuster version 1.3.0.0.

- **Added the [Colorimetry] function.**

The **[Colorimetry]** function measures the colors on a printed test chart at a regular interval. You can save the measurement results in a file and manage them using a color management or another similar application.

## Known Limitations, Problems, and Workarounds

### **During Quick Color Adjustment, the scanning process becomes slower starting with the second page**

During Quick Color Adjustment, do not overload your computer with other simultaneous tasks that can use up your computer resources.

## **Opening multiple Color Sample Matching instances simultaneously might cause unexpected results or errors**

While using the Color Sample Matching function, make sure you have just one Color Sample Matching instance open.

## **Data format in Color Sample Matching**

The Color Sample Matching function does not support data containing RGB, DeviceN, or gray scale.

## **The logs can use up your computer free space**

If your disk space is full, you can manually delete the logs from the following folders:

- Logs saved during color verification: C:\RicohAutoColorAdjuster\ChartLog\calib
- Logs and data saved during scanning: C:\RicohAutoColorAdjuster\ChartLog\data
- Images saved during Color Sample Matching: C:\RicohAutoColorAdjuster\hotfolder\_ColorMatch
- Stored prejudgement data: C:\RicohAutoColorAdjuster\dat\_SAVE
- Stored verification data: C:\RicohAutoColorAdjuster\it8\_SAVE

| RL3-4  | “Unhandled error occurred” message is displayed and color profile is not registered for TotalFlow Print Server when the first attempt to register fails.   |
| RL3-6  | Application is registering color profile to the wrong DFE when using Quick Color Adjustment function if the first server from Fiery Command WorkStation (CWS) list is stopped and the CWS window is behind the ProductionServer windows when registration starts.  |
| RL3-8  | Ricoh Cloud Connector is not uninstalled correctly when called from the Ricoh Auto Color Adjuster application installer.   |
| RL3-12 | ColorGATE Productionserver settings, including password, are not restored from backup correctly, causing Quick Color Adjustment to fail.   |
| RL3-13 | Attempting to use file names that contain old multibyte characters that cannot be converted to Shift-JIS characters with the Color Sample Matching function will result in a fail to open PDF file with an error message (either the file format is not supported or the file has been corrupted). The appropriate message should be: "The file name includes invalid characters". |
